We appreciate your continued support and participation in our Northeast trips. We know that many of you follow us in our efforts to put together cost effective ski trips. We believe that this trip will sell out quickly and you are encouraged to sign up ASAP.

**Please note that NJSSC club members will have the first opportunities to sign up for this trip. While other non- NJSSC people may send in their reservation forms, they will be held until June 10, so that our members get first choice. Additionally, we recognize that many non-skiers may want to attend this trip. Please note that this trip is run by New Jersey Ski and Snowboard Council for our skiers. Therefore, a NJSSC member may bring their spouse/partner/friend, who is not a member. However, only 1 non-member may be in a double or triple room, as only double or triple attendance is being offered.**

Attached is the Flyer and the Reservation form for the Mt Washington Hotel/ Bretton Woods trip! **Every person attending the trip must complete a reservation form. Two people cannot put their names on 1 form. Also, all lines on the form must be completed and you need a witness to sign and date and print their name on the form. We would like two emergency contacts of people not attending the trip. You must sign up with all people in your room and each must send in \$100 pp. You cannot hold a double or triple room with a \$100 deposit as your roommate must also sign up and send in their deposit. This trip sells out quickly, so I suggest getting your forms/deposits early!**

The Mount Washington Hotel opened for its "First Winter" season ever, beginning Thanksgiving Day, 1999! The hotel has been host to countless celebrities, including Thomas Edison and three U.S. presidents, and Kathy Mancini and Ed Dalton! (LOL) Make sure that you take advantage of free tours of the Hotel each day. There is the CAVE in the evening for drinks. It is across from Stickney's on the Patio level of the hotel. The Cave is a prohibition-era speakeasy with stone walls featuring live evening entertainment and televised sporting events on select evenings! Since our last visit in 2019, the Mt Washington Hotel has undergone extensive renovations and improvements. In addition, the Bretton Woods Ski area added a GONDOLA to bring you up the mountain. There are also variety of eating places at the mountain.

All lift tickets for Bretton Woods (BW) are \$42 per day. Sunday – Friday. You must order your Sunday lift ticket separately from the week days ones. 80 and over ski FREE at BW with proof of ID, driver's license or passport. This trip is for ADULTS ONLY, please no children are permitted.

Also, Loon is AN IKON mountain that is 1/2 hour away. Loons is also FREE for 80+. Both Attitash and Wildcat are EPIC mountains that are about 30-40 minutes away.
