## 2024 Mt Tremblant Ski Trip by New Jersey Ski & Snowboard Council January 28-February 2

By Signing below, I enroll in the trip to Mt Tremblant being offered by the New Jersey Ski & Snowboard Council (NJSSC). I agree to comply with the rules & regulations of Mont Tremblant Resorts and Company, LP/Holiday Inn Express & Suites (referred to as MTRCLP/HIE) & Mt Tremblant. The 1 Bedroom "2 Double Bed Suite" has 2 Double Beds in Master Bedroom, full kitchen, Living Rm (double sofa bed (SB)) & Fireplace. (Ski In/ Ski Out). All rooms have hair dryer/iron/ironing board. If you are not a member of a club belonging to NJSSC, add \$25 as Non-NJSSC member. **FEE for Underground Parking is 23.68\$ per day per vehicle.**
